

Conditions of participation

Preamble:

As part of the “AFR Referral Program” campaign, participants can recommend potential hangar users / tenants or prospective tenants via a recommendation tool provided by Airfield Rottweil GmbH & Co KG (hereinafter: “AFR”) on the website (<https://airfield-rottweil.com/hangar-referral/>) by disclosing and transmitting the relevant contact details and receive a reward for this.

1. Conditions of participation

The following terms and conditions govern participation, receipt of the bonus and the legal relationship between the participants and AFR.

By participating in the “AFR Referral Program”, the participant accepts the exclusive validity of the following conditions of participation.

2. General information, conditions of participation

2.1. The transmission of a contact does not establish a brokerage or other contractual relationship between the participant and AFR.

2.2. In particular, the participant is not authorized to make or receive legally binding declarations in the name and on behalf of AFR.

2.3. Both companies and natural persons are entitled to participate in the “AFR Referral Program”.

The latter must have reached the age of 18 at the time of participation.

3. Successful referral

3.1. A successful referral is one in which the following conditions are cumulatively met:

Forwarding of the referral link to one or more other persons

Calling up the hangar request page (<https://airfield-rottweil.com/hangar-referral/hangar-inquiry/>) using the generated link by the link recipient(s)

Completion and submission of the form by the link recipient(s) (only one form per sender)

3.2. A successful recommendation is excluded if and insofar as AFR was already aware of the named contact. In particular, the contact is already known if it has already been registered by a previous referral link activated by the interested party concerned

3.3. AFR alone shall decide whether to enter into a business relationship with the disclosed contact.

4. Reward, receipt of reward

4.1. The bonus consists of:

Optionally

1x baseball cap with AFR logo or

1x LED knitted cap with AFR logo

4.2. AFR will inform the referrer in writing by e-mail that the conditions for receiving the reward in accordance with section 3.1 have been met.

4.3. The reward will be sent within 14 calendar days of the aforementioned notification.

5. Data protection

5.1. Personal data transmitted to AFR will be used exclusively for information and contact purposes in order to enable the initiation of a contractual relationship or to fulfill a contract (Art. 6 para. 1 lit. b) GDPR). 6. Liability, exclusion of liability

6.1. AFR's liability for any damage to property and/or personal injury of any kind, including any consequential damage, is expressly excluded to the extent permitted by law. This shall not apply where liability is mandatory, e.g. under the German Product Liability Act (ProdHaftG), in cases of intent, gross negligence, injury to life, limb or health and due to the breach of material contractual obligations.

6.2. However, any claim for damages for the breach of essential contractual obligations is limited to the foreseeable damage typical for the contract and does not include atypical, indirect or consequential damage, in particular loss of profit or loss of savings.

7. Final provisions

7.1. Recourse to the courts is excluded.

7.2. The law of the Federal Republic of Germany shall apply.
